To All Political Subdivisions:

Contracts will be activated by July 1, 2009 for DOT and all entities that accepted bid prices for salt for the FY2010 contract year. All Political Subdivisions are responsible for contacting vendors to place orders for salt after July 1, 2009.

A minimum of 20-25 ton shall be ordered to accommodate full truckloads. Political Subdivisions are obligated to purchase 80% of the estimated tonnage listed on the proposal. Salt vendors are responsible for supplying up to 120% of the estimated tonnage listed on the proposal.
