Contractors shall conduct direct and systematic recruitment of employees, if needed, through public and private referral sources likely to yield qualified minority group applicants.

In order for the sources to be capable of referring qualified persons, it is necessary that specific notice be given in advance of a hiring period detailing the anticipated job openings, qualifications, hours and salary ranges. When any unexpected vacancies occur (not included in any advance announcement) notice must be given to each of the referral sources about the specific requirements and duties of the job.
