- i. Working with Iowa Total Care on a project with Lyft Healthcare
 - 1. This partnership gives the MCOs the ability to utilize Lyft Healthcare as a transportation option
 - 2. Hoping to see a decrease in "abandoned trips"
 - 3. Decided on Lyft Healthcare over Uber Health because it's credentialing is very similar to the State of Iowa's
 - 4. This is a pilot project and Lyft is only going to be used for ambulatory services
- Christy Casey
 - i. Working on the HCBS waiver design and should be rolled out in the next two years
- Vienna Hoang
 - i. Went through the streamlining process and now officially apart of Iowa Workforce Development
 - ii. Disability Innovative Funds
 - 1. First collective meeting
 - 2. 14 million dollar grant (over 5 years)
 - 3. Right now, they are focusing on the most significantly disabled group, but would like to expand out to a wider range of the population
